- 4. **Application**. Anyone wishing to participate should complete the SHS Participation Application Form. Further details are contained therein.

- 6. **Safefield Farm**. Safefield farm is a working farm with residential properties adjacent to the complex. Please be aware and respectful of any farming activity that is being undertaken when entering, moving around and departing the farm. Please also be respectful of residents and their properties. The farm access road is single track, please do not exceed 20 mph. When walking to/from the excavation location, please keep to the edge of the field.
- 7. **Fenland Young Archaeologists' Club (YAC)**. Children from Fenland YAC have been invited to participate on 2 Aug 25 during the period 1000-1200. The children will be supervised by Fenland YAC adult leaders.
- 8. **Visitors**. The site will be open to visitors on an *ad hoc* basis.
- 9. Welfare.
 - a. Toilet facilities are available in the barn complex (see Attachment 2).
 - b. Participants should bring their own food and drinks or be prepared to purchase from nearby commercial outlets in Alconbury Weald (Co-op) or Tesco (Huntingdon). Participants should also bring additional water or other drinks; excavation can be physically demanding, particularly at this time of year, and requires regular rehydration.
 - c. Participants should wear sturdy and comfortable outdoor clothing and footwear (walking boots, steel capped boots, Doctor Martens boots, wellington boots,

- etc). Layered clothing allows for personal comfort to be maintained as weather conditions change. Waterproof jacket (with hood) and trousers should also be brought as excavation will continue during showers and light rain.
- d. Participants may wish to bring other items for personal comfort, such as; small camping chair to sit on during breaks and lunch, kneeler or knee pads, gloves, hat, scarf.
- e. Participants are responsible for bringing any medication they will need and for having an up-to-date tetanus inoculation (refer to your doctor or surgery nurse if in any doubt).
- 10. **Archaeological Equipment**. All relevant equipment will be provided by SHS. However, please feel free to bring your own equipment.
- 11. **Insurance**. Volunteers will be covered by SHS insurance, which includes both Public and Employer's Liability. YAC children and adult leaders will be covered by their own insurance. Those taking part may, however, wish to consider their own personal accident insurance and should seek advice from an insurance company beforehand to ensure the correct type and level of insurance is purchased.

12. **Evaluation Excavation Aims**.

- a. **Strategy**. This is the second session of the third season of archaeological investigation on Safefield Farm, which is a continuation of the desktop survey (Season 1) and an earlier evaluation excavation undertaken in Oct 22 (Season 2). The purpose of this session is to determine the nature of the mortar feature revealed in the previous session, its stratigraphy relative to the remainder of the trench, and whether the yellow clay associated immediately north of the mortar feature is natural geology. It will also continue to locate the accumulated Roman/Romano-British pottery assemblage discovered by Landowners Historical Research Group (LHRG) detectorists.
- b. **Development**. This excavation will give volunteers with excavation experience the opportunity to develop their excavation skills and techniques.
- c. **Training**. This excavation will give volunteers with no excavation experience the opportunity to learn the principles of archaeological excavation, and basic skills and techniques.
